# Notes from the 1999 Championship Director

**D**ear Ride & Tie Family,  
By now your taxes are done and you are making plans for this year's Championship race! You have been running and riding hard, your partner is keeping his/her word about joining you in your training, and things are looking good, right? You received your February Newsletter with the entry form, and you put it in a prominent place so you'll remember to send it in time for the reduced rate, right? You reviewed the list of accommodations and have called for reservations, right? Right!

Well, if you're like me, you have excellent intentions for all of the above, but you may have done just one or two of the above. Set your own priorities, but I encourage you to make those reservations ASAP! I have one more addition to the list of accommodations:

- Rocky Point Resort (541) 356-2287. Nine miles west of the race site, there are four cabins; 1 bedroom (sleeps 4) \$75; 2 bedroom (sleeps 6) \$95. Motel rooms are \$55.

Identify yourself as part of the Ride & Tie for special rate of \$60 on availability. There are also condos for rent: \$200/night for 2 bedrooms and \$250/night for 3 bedrooms.

- Econolodge (800) 446-6900 or (541) 884-7735. Special rate of \$38/night or \$190/week for room with 2 beds.

- Red Lion Inn (800) 773-5466 or (541) 882-8864. Regular rates \$74-\$99.

- Best Western Olympic Inn (800) 528-1234 or (541) 882-9665; regular rate of \$61.

**The clinic that was planned for April 23** at the Rock Creek Ranch (17 miles northwest of Klamath Falls on Highway 140) has been postponed until May 22, due to weather considerations. Mary Tiscornia and Steve Shaw will demonstrate technique and discuss strategies, and we'll review a loop of the course – about 10 miles.

# Reports from Afield

## Rogue RATs Challenge: Headwaters of the Rogue . . . Best Scenery Award by Annette Parsons

**O**kay gang...we're out here! We are the Rogue RATs, and here in southern Oregon, we put on the most scenic Ride & Tie of the season! But then, we're not biased or anything.

So how come more of you RATs haven't been seen in these parts? It's your loss! Our Pacific Crest Ride and Tie will be in its fourth year in 1999...oh, but now we're calling it "**Headwaters of the Rogue**" because we've changed the location.

### A Brief History

Way back in 1996, Dr. Ann Swartz, a veterinarian from the Ashland area, began the tradition of a Ride & Tie in southern Oregon by holding a 10-mile R&T fun race the day after the Pacific Crest Endurance Ride in July of that year. The base camp was about 30 minutes east of Ashland, located in a horse camp in a beautiful meadow called Lily Glen, and the spectacular views of Mt. McGloughlin from along the trail caused more than a few of us to trip as we ran.

Me and my husband, Jim Clover, were newcomers to the area and were delighted to have an event close to our new home. We had become spoiled down in the Sierras with all those Ride & Tie races so close by! We were so delighted, in fact, that we offered our help to Ann for an event the following year. And so it began. Silly us!

In July 1997 we (Rogue RATs) hosted the first sanctioned Pacific Crest Ride & Tie. That year the endurance ride that was also supposed to occur that weekend got canceled so we had to hustle all the camp and trail details ourselves. We managed it (barely!) and were pleased with a turnout of five teams in the 30 miler and eight teams in the 10 miler. The weather was perfect, the course was beautiful and not too tough, the camp was wonderful, and everyone had a great time! We had great support from local businesses, and I don't think there was a single participant who left without an award of some kind! Lew Hollander and Doug Madsen won it that year on

Miss P (also BC!), followed by Ted Ruprecht and Elaine Howard Ruprecht on Rapscaillon. Jim Clover and first-time ride & tier, Marilyn Wallendy were close behind on Bones.

Fourth team in was Steve Andersen and Debbie Hansen-Bernard on Sunny. And last but not least was yours truly and Michele Jay on Saki. (Michele's first ride & tie was the Bloomfield Boogie in 1995, which she completed with Jim. Michele also completed the Fort Bragg Championship in 1997 with Sheryl Soto, another of our Ride & Tie inductees.)

The eight teams who completed the 10-mile course that year ranged in age from eight years to over 60! Most of them were newcomers to Ride & Tie and we hope they will be back for more! They were troopers. Many of them became lost in the big meadow...I humbly apologized, and blamed it on the cows that ate the flagging. My only consolation I could offer was that my partner too got lost! (That was also my excuse for finishing last!)

1998 brought us back to the Lily Glen horse camp in July for the second sanctioned Pacific Crest Ride and Tie. We added some new sections of trail, and some of the local endurance riders were invaluable with help along the lake trail. For those of you who have not ridden it, it is truly a beautiful stretch of trail, the result of a pro-active local Rogue Riders endurance club and cooperative BLM recreation staff. This loop left camp and headed to the Pacific Crest Trail for a few miles, after which the rugged but spectacular lake trail led finishers back to camp.

We had a smaller but no less enthusiastic turnout of participants in '98, and once again Lew, Doug, and Miss P finished first. This time Jim re-drafted a former ride & tier from way back, Robert Hoogendyks; they finished second on Bones, and Bones received BC. Ted Ruprecht and Marlene Allen were third on Rapscaillon. My partner this time was another novice, former neighbor Debi Wagner from down in the Sierra. I failed her, as I had to drop out after 10 miles

due to foot problems...seems I am always making excuses, huh? It's fixed now, though, so Mountainside, here we come! Four teams entered the 10-mile novice race, this time ranging in age from 6 years to over 60! Once again, no one went away without an award of some kind and a great time was had by all!

### This Year's Race

1999 brings us to a new location...even more gorgeous, if you can imagine! We are holding the ride & tie in conjunction with the Headwaters of the Rogue endurance ride on August 28, on some of THE most beautiful trails in the northwest. Base camp is along the edges of the spectacular Hammaker Meadow, located on the Rogue River National Forest off Highway 230 northwest of Crater Lake.

The ride & tie will take place along 30 miles of the 50-mile endurance course. The Forest Service has done an outstanding job of constructing and maintaining an extensive system of scenic trails. You'll traverse the Mine-haha Creek loop, the Muir Creek trail, and Buck Canyon. Most of this course will be dirt trail, the terrain is moderately challenging, and water is plentiful. The weather should be perfect. Generally it is sunny and warm but not hot, as the elevation there is around 4000 feet. You will definitely wish you had your camera if you don't bring it!

So come on up to southern Oregon and Ride & Tie with us! After you get a taste for this country when you come up to Klamath Falls for the Championship in July, you will wonder why you haven't come up more often! Help us make our 3<sup>rd</sup> Annual Headwaters of the Rogue (formerly Pacific Crest) Ride & Tie the biggest and best ever!
