VETERNARIAN'S CORNER

AIMING FOR THE CHAMPIONSHIP

At the time of this writing, we are some 2 months from the 2012 Ride & Tie Championships to be held at Bandit Springs, in central Oregon. There is a large group of people who have been working in concert for months to make this event a successful one. They include your Board members, our Ride Manager, Jannelle Wilde, and her team, myself, serving as head veterinarian and other folks as well.

Our veterinary team for the Championships will be Dr. Rob Lydon, from Manton, CA, Dr. Cassee Terry, from Redmond, OR and myself. Many of you probably know Rob, as he is a veteran ride & tier. Cassee is our local connection, has vetted several endurance rides in that area, teaming up with Jannelle, and will be our designated treatment veterinarian, if needed. We have been in communication with Jannelle about the course and have the loops all laid out, with the locations set for the different vet checks. It feels like plans, from our perspective, are progressing well, and I'm very pleased with the vet team we will have for this year.

So how are your plans progressing? For most of us, by far the most important and most time consuming issue is conditioning. And that's for both horse and human. Make an honest assessment of where you and the horse you will be teamed with are realistically at right now. Know that you can only increase mileage safely about 10% per week. Work backwards from a week before July 21st and do the math. One of the keys to an enjoyable and safe competition is coming in knowing you both are prepared to meet the physical challenges of a champion-ship course.

For the horse, coping with the mental demands of the competition can be as challenging as the physical ones. There're lots of strange horses around. Is your horse prepared for that whole package of taking off with the pack, stopping and being tied while watching the world rush by, rushing off again, then having to stand still for a P&R and a vet check, quickly eating and drinking, having their buddy take off without them, and all that stuff? From my observations, difficulties in this area cause more problems than do possible fatigue, dehydration or metabolic stress.

There are other areas of planning to get in order and not leave until the last day before leaving. What is the shoeing cycle for your horse? Do you have it set up so that the last shoeing is about 2 weeks before the competition? The same should be said for vaccinations and worming. Annual vaccines should be done in the spring, but make sure they are given at least one month ahead for optimum protection and have the time to recover from any possible side effects. Consider "rhinopneumonitis" among your vaccine arsenal, as there have been at least 2 outbreaks of the neurological form of EHV1 in different parts of California this year. UC Davis issued a very informative White Paper on Equine Herpes Myeloencephalopathy (EHM), dated May 26, 2011. Although there are no vaccines labeled for use against EHM, they discussed the possible benefits of some of the brand name vaccines (Calvenza, Rhinomune, Pnuemabort K, Prodigy).

Check on Oregon's requirements for transport of horses into the state. There are no requirements for horses coming from Washington. For most of the western states, a health certificate is good for 6 months and a Coggins test is good for a year. The common standard from other states is a Health Certificate within 30 days and a negative Coggins test within 12 months, but double check with your vet so you don't get caught with a surprise.

Speaking of travel, most of us will be coming from quite a distance to get to central Oregon. Don't underestimate the stressful impact on our horses of riding in a trailer for many hours or even more than 1 day. Simply riding in a trailer requires constant rebalancing, so it's far from restful. Eating and drinking are completely changed from normal routines. A rule of thumb is that the horse will need at least as many hours to recover, rehydrate and re-establish normal gut function as the trip took.

Speaking of eating and drinking routines, how does your horse do when asked to drink different smelling/tasting water in different containers in any location? Is your horses used to drinking any time along the trail? Bring with you the hay and feed they are accustomed to eating. Same with vet checks for that matter. What are

they used to during competition at vet checks? What is your plan concerning electrolytes? Have you practiced that plan during training rides? Or before and/or after riding?

I think I've offered more questions than answers. However, my main objective is to get you to consider a lot of this and to try to address as much as you can with the time remaining.

Best of luck to each of you. I'll see you at Bandit Springs in July.

SUN RISES ON SUNRISE CANYON

WOW! What a great showing we had for the Sunrise Canyon Ride & Tie on March 24, 2012. We had eight teams complete the Short Course (11 miles) and 1 team complete the Long Course (22 miles). As a direct result of this race, we had 12 new R&T members and have three or four of the teams committed to doing the Championship. All of the finishers received a custom wood frame and a photo from world-famous photographer Libby Volk. (All right, she's not world- famous yet, but some day she will be!)

The race started with the usual excitement from ride camp in Sunrise Canyon, located next to Ira and Leslie Hickman's house. True to the ride name, the sun came up through the canyon about 8:00 a.m. and took the chill off the air. We still faced a 5-10 mph wind throughout the day, but the sun seemed to help keep the chill out of the air and made for perfect race conditions. Despite the lack of trees, all of the teams noted that they were able to find ample tie points.

The long course was dominated by the dynamic duo of Dick Root (68 years young) and Rachel Toor (50 years young). With well over 100 years in the saddle, this seasoned team even challenged the short course winners, Shelly Yorgesen and Ben

Volk, on their first two loops of the course. The course consisted of an 8-mile loop with a 1500 foot climb and a 3-mile loop with 300 feet of climbing. With both teams riding horses Will and Bubba, highly trained by

Dick Root, this was bound to be an exceptionally fast day. Shelly, Ben and Bubba made it to the finish with Rachel, Dick, and Will right on their heels. As Rachel and Dick headed out for the next 11 miles, the 2nd through 4th place short course teams came steaming into camp. It was literally a photo finish as all the runners came in together followed by all three horses finishing within seconds of each other. All of the teams finished and Kadin, ridden by Kirsten Seyferth and Liza Linda, won the coveted Best Condition Award. All of the teams had a blast and vowed they would be back for more. Fair warning to those "Century in the Saddle Teams": Dick Root and Rachel Toor are teamed up for the Championship!



Camp Information

Camp Opens Sunday July 15th and is located in Central Oregon's beautiful Ochoco National Forest, 28 miles east of Prineville, OR - Ride Camp GPS coordinates: 44-28-00 N 120-22-19 W

The camp is in a large, grassy meadow dotted with old growth ponderosa pine and aspens. Horse water and porta-potties provided. Please bring your own people water. Cell phone service is spotty.

Bag and remove all horse poop and hay!

ALL DOGS ON LEASHES

The U.S. Forest Service mandates that all feed used on USFS lands be certified weed seed free. We are required to have weed-free hay in ride camp. You are welcome to bring your own if it has the special yellow and purple strings indicating it is certified. We will also have bales for sale from a local grower.

1.Please do not tie your horses to trees in camp. There are hitching posts, steel pens and your trailers for that.

2. Dogs are allowed ONLY in camp. A dog out on the trail could jeopardize the event.

3.Dogs in camp must be on a leash and under the control of the owner at all times. This seems pretty clear. No loose dogs.....ever.

4. And please, don't throw your dog in the trailer and ride off for two hours leaving it there howling. The park ranger comes looking for me to find out which part of the rules I didn't understand.

If you are coming on I-84 or other points northeast, take Hwy 395 south to Hwy 26. The turnoff is about 19 miles southwest of Mitchell.

Turn southeast off 26 onto USFS Road #2630 (watch for signs and ribbons) and go about 2.5 miles. Look for ride camp on your right.

Farewell, My Friend

Note: The following was written by Ira Hickman in early April of this year, just after he lost his beloved Ride & Tie horse, Dartanion, to injuries sustained in a serious accident while out on a training ride. Here, Ira bravely shares his experience in the hopes it may save another horse from a similar tragic fate.

Thad a bad wreck on Dart today. I'm okay but I had to put him down. I took several pictures with my phone Lebecause I knew this would be the last time I would see him. About two miles from the house he got his hind leg caught in a single strand of barbed wire. It was flat on the gound and the remnant of an old fence line. I was dismounted and leading him over it. I've done this a hundred times on at least six different horses. I won't do it again. He hooked the wire with his foot somehow, even though I was standing on it just in case. I tried to hold him back but he bolted over me and dragged me underneath him with the wire. He dragged me about 20 yards under him in the wire and crossed back through the fence line which was still standing farther down the hill. I never let go of the reins in an effort to keep him from hurting himself and for fear of getting dragged in the wire that I was also in. I got stepped on several times, and kicked in the head a few times. I'm a bit cut up from the wire but seem to be fine. Dart severed both tendons in the front of his left hind leg and more. Ironically, I usually carry wire cutters but had untied them from my saddle a week ago when I loaned it to someone during a ride & tie. It probably wouldn't have mattered in the long run. I got on my cell phone and called my neighbor, Ken Egli, to help me and bring some wire cutters. I also called Dr. Dick Root, the vet. By the time they got to me I had already gotten Dart free. It took about 25 minutes or so to work the loose end of the wire back through the cinched up knot around his leg. He was sitting on his butt and laying over against me. The wire was stretched tight back to the last post and looked like a combination clove hitch double timber hitch around his leg. His tail was also tangled into the whole bloody mess. I didn't think I'd ever get it off him. Ken and Dick showed up about 15 minutes after I got it off. The only good news was that I didn't really get hurt. Dart was a great horse and a good friend of mine. I feel like I really screwed up. I wish I could have done more for him and kept him out of trouble in the first place. I spent a lot of time traveling with him and on him. I already miss him. I'm glad I had the privilege of spending time with him the last few years. I told him I was sorry and I would see him on the other side. Then we put him down.




